

Linde (NYSE: LIN) announced today that it has signed a long-term agreement with ExxonMobil (NYSE: XOM) for the off-take of carbon dioxide associated with Linde's new clean hydrogen production in Beaumont, Texas.

IRVING, Texas – CF Industries, a leading global manufacturer of hydrogen and nitrogen products, has entered into the largest-of-its-kind commercial agreement with ExxonMobil to capture and permanently store up to 2 million metric tons of CO₂ emissions annually from its manufacturing complex in Louisiana. Start-up for the project is scheduled for early 2025 and supports Louisiana's objective of net zero CO₂ emissions by 2050.
